Proposal to transfer CGU Insurance Limited business into Insurance Australia Limited

What is happening?

CGU Insurance Ltd ABN 27 004 478 371 will apply to the Federal Court of Australia to transfer all of its insurance business into a related company Insurance Australia Limited ABN 11 000 016 722 (IAL) on or about 1 August 2017. CGU's application is one of seven happening at the same time, as separate IAG businesses are transferred into IAL.

What does this mean for me?

The proposed transfer will have no impact on you as a CGU customer. The terms of your policy will not change after the transfer date other than IAL becoming the insurer under your policy; you can continue to contact us in the same way that you do now; there will be no impact on claims; and your policies will continue to operate and be renewed in the same way.

Why are we doing this?

CGU is part of Insurance Australia Group Limited ABN 60 090 739 923 (IAG). Businesses within IAG currently have nine separate insurance licences. IAG is working to become a simpler, more efficient and agile business. Reducing the number of insurance licences we hold will help to achieve this, and will contribute to us providing a better service to customers.

What happens next?

Transferring CGU's business into IAL requires a scheme which has to be confirmed by the Federal Court of Australia before it can take effect. If the scheme is confirmed, IAL will become the insurer for all the policies issued by CGU from the date the scheme is confirmed. There are seven schemes happening at the same time, one for each of the separate IAG businesses that are being transferred into IAL; CGU Insurance Ltd ABN 27 004 478 371; Swann Insurance (Aust) Pty Ltd ABN 80 000 886 680; WFI Insurance Ltd ABN 24 000 036 279; CGU-VACC Insurance Ltd ABN 73 004 167 953; Mutual Community General Insurance Pty Ltd ABN 59 007 895 543; HBF Insurance Pty Ltd ABN 11 009 268 277; IAG Re Australia Ltd ABN 96 001 948 278.

We expect the Court hearing to take place in July 2017.
